It is stated that the Inspection Committee which visited your Institute to verify the compliance of previous conditions of affiliation for the existing courses has submitted its report. The report of the Inspection Committee has been considered by the Vice-Chancellor. On the basis of the recommendations made by the Inspection Committee, the Vice-Chancellor has been pleased to grant ex-post facto extension/continuation in provisional affiliation for the following existing courses/intakes in **School of Engineering and Technology, Vill. Soldha, Bahadurgarh**

Badli Road, Distt. Jhajjar for/from the session 2015-16 to 2018-19:

B.Tech/UG Courses :

CSE - 60 seats (2015-16 to 2018-19)
ECE – 60 seats (2015-16 to 2016-17), 30 seats (2017-18 to 2018-19)
ME - 60 seats (2015-16 to 2018-19)
CE – 120 seats (2015-16 to 2016-17), 90 seats (2017-18 to 2018-19)
EE – 60 seats (2015-16 to 2016-17), 30 seats (2017-18 to 2018-19)
BBA– 60 seats (2015-16 to 2018-19)
BCA- 60 seats (2015-16 to 2018-19).

M.Tech./PG Courses :

CSE – 24 seats (2015-16 to 2018-19)
ECE – 24 seats (2015-16 to 2018-19)
EPS (2nd shift) – 24 seats (2015-16 to 2018-19)
M&A (2nd shift) – 24 seats (2015-16 to 2018-19)
MBA – 60 seats (2015-16 to 2017-18), 120 seats (2018-19)

Inspection Report - School of Engineering & Technology, Soldha, Bahadurgarh-Badli Road, Bahadurgarh, Jhajjar in view of the request of DGTE, Haryana and also to consider the matter regarding grant of ex-post facto extension/continuation in provisional affiliation for the existing courses/intakes in the said college/Institute for the session 2015-16 to 2018-19.

The Inspection Committee comprising Prof. Rajender Singh Chhillar, MDU Rohtak, Mrs. Isha Verma, UIET, Dr. Savita Khatri, UIET, Dr. Sandeep Kumar, UIET, and Dr. Gurdiyai Singh UIET, MDU Rohtak visited School of Engineering & Technology, Soldha, Bahadurgarh-Badli Road, Bahadurgarh, Jhajjar on 23.2.2019 in view of the request of DGTE, Haryana and also to consider the matter regarding grant of ex-post facto extension/continuation in provisional affiliation for the existing courses/intakes for the session 2015-16 to 2018-19.

Observations

The observations of the committee are as under:

1. **Compliance:** The Institute has partially complied with the show cause notice of DGTE, Haryana and the conditions imposed by the AICTE and earlier MDU committee. The appointment of the faculty and senior faculty lacks as per AICTE prescribed cadre ratio.
2. **Admissions:** The Institute could not attract full intake admissions in the courses being run by it during the sessions 2015-16 to 2018-19.
3. **AICTE Approval:** AICTE has granted approval to the said Institute for running the existing courses with sanctioned intake. **(Details enclosed)**
4. **Building and Space:** The institute has a good building housing School of Engineering & Technology. The space is adequate in terms of built-up area as per AICTE norms for existing courses. The Institute has required number of classrooms, Tutorial Rooms, Workshop, Laboratories (for all disciplines), Library, Drawing Hall, Seminar Hall etc. **(Details enclosed)**
5. **Location:** The said Institute is located on Bahadurgarh-Badli Road of Distt. Jhajjar, which is well connected.
6. **Staff:** Besides Director, the institute has in all 99 existing faculty (1 Professor, 1 Associate Professor, 97 Assistant Professors). Out of these, 22 faculty is university approved. Appointment of Director is also University approved. However, the institute is required to ensure appointment of qualified faculty as per MDU/AICTE laid procedure and also in the prescribed cadre ratio. All the faculty should be got approved from the University. There are 21 non-teaching staff including Technical and Admin staff. **(Details enclosed)**
7. **Computing Facilities:** There are in all eight Computer Labs having in all 350 computers, 13 printers and required power backup. The institute has already arranged 50 MBPS RF Link Internet connection from Airtel, which needs to be properly accessible in all the computer labs. Apart from open source software, the institute has procured few licensed software like MATLAB, AutoCad. Therefore, the Institute is advised to procure all the deficient licensed software required for all the existing courses and labs. **(Details enclosed)**

8. **Library:** The Institute has a common Library having total 38098 books with 3105 titles for all existing courses being run by it. The institute has subscribed to 127 National and International Journals and Delnet E-journals. However, the institute should add 100 more titles to strengthen the library. The Institute has also subscribed to DELNET E-resources. There is adequate seating space in the Library. **(Details enclosed)**
9. **Laboratories:** The institute has set up various labs required for CSE, ECE, ME, EE, Civil Engg. (CE), M.Tech., MBA, BBA and BCA courses being run by it. However, some labs of ECE, EE and CE requires up-gradation in terms of devices and softwares.
10. The Institute has made permanent arrangement for potable water on the premises and RO system is also made available.
11. The Institute has got an Electric connection of 125 KVA for the Campus. The Campus has 2 Gen Sets of total 94.5 KVA capacity.
12. The institute has good Transport facilities for students and staff having 13 buses.


Recommendations

In view of the above observations, the committee recommends that the School of Engineering & Technology, Soldha, Bahadurgarh-Badli Road, Bahadurgarh, Jhajjar may be granted ex-post facto extension/continuation in provisional affiliation for the existing courses/intakes for the session 2015-16 to 2018-19 subject to compliance of the deficiencies pointed out above by the committee at the earliest.
